## **CRRA Mid-Connecticut Project Recycling Facility Facts**

Location: 211 Murphy Road, Hartford, Conn.

Size of facility: 67,000 square feet

Originally designed and built by: RRT Design

**Opened:** 1992

**Items processed at this facility 1992-2007:** Aluminum cans, steel cans, glass bottles and jars, bottles and jars made of plastics #1 and #2, aseptic packages

Facility recycling capacity 1992-2007: 55,000 tons of containers per year

**Retrofitted:** 2006-2007, 2008

Retrofits designed and built by: FCR, Inc., a subsidiary of Casella Waste Systems.

**Purpose of 2006-2007 retrofit:** To combine container and fiber processing in one building, increase menu of recyclables.

Cost of 2006-2007 retrofit: \$6 million, paid by FCR – retrofit completed at no cost to member towns.

Purpose of 2008 retrofit: To accommodate single-stream recycling deliveries.

**Cost of 2008 retrofit:** \$3.5 million, paid for by CRRA from facilities modification reserves. Single-stream proven to generate increased recycling, and additional tonnages will repay cost in less than 10 years.

**Processing technology in retrofitted facility:** Optical sorting for plastics; disk screen to separate cans and bottles from paper and cardboard; disk screen to sort types of paper and cardboard; eddy current separator to automatically sort aluminum; glass beneficiation to create useable product.

**Items now processed at this facility:** Aluminum cans, steel cans, glass bottles and jars, bottles and jars made of plastics #1 and #2, aseptic packages, newspapers, mixed paper (i.e. junk mail, magazines, catalogs, office paper), corrugated cardboard, chipboard (also known as boxboard, i.e., cereal boxes, shoe boxes, shirt cardboard)

**Capacity post-retrofits:** Containers – 55,000 tons per year; paper and cardboard – 100,100 tons per year

Facility operated by: FCR, Inc.

Employees (as of May 2007): 32

## Employees (when facility reaches operating capacity): 66

**Towns served:** 64, including Avon, Barkhamsted, Beacon Falls, Bethlehem, Bloomfield, Bolton, Canton, Chester, Clinton, Colebrook, Cornwall, Coventry, Cromwell, Deep River, East Granby, East Hampton.
