This Addendum consists of the Connecticut Resources Recovery Authority's (CRRA) responses to written questions that were received by CRRA by the 3:00 p.m., August 14, 2008, the deadline specified in the Instructions To Proposers for the submission of written questions.

1.	Question	What are the expiring premiums?				
	Answer	Total amount of premium for 2007-08 is \$1,831,346				
2.	Question	What is the expiration dates for all coverages that are being bid on?				
	Answer	04/01/09 – Property; Public Officials; Fiduciary; Crime 07/01/09 – Workers Compensation/Employers Liability 10/01/08 – General Liability; Auto Liability; Excess/Umbrella; Pollution Legal Liability				
3.	Question	Please provide loss runs for the last 5 years.				
	Answer	CRRA will not provide loss runs until broker/consultant is selected.				
4.	Question	Please provide copies of policies involved (language is critical in this case).				
	Answer	CRRA will not provide copies of policies until broker/consultant is selected.				
5.	Question	There appears to be no language regarding commercial auto - is there any?				
	Answer	Commercial Auto is a policy that CRRA purchases.				
6.	Question	Please provide addresses of all locations CRRA is managing/operating/owns.				
	Answer	See attached project booklet.				
7.	Question	Please provide payroll figures of each classification.				
	Answer	Payroll figures for each class will not be provided until broker/consultant is selected; insurance is not being placed at this time. Total payroll is approximately \$4.5 million.				
8.	Question	Is CRRA assigning carriers to brokers?				
	Answer	No. The broker/consultant selected will be expected to market all lines to as many carriers as possible to insure that CRRA receives the best coverage for the most economically advantageous price.				

9.	Question	Can you confirm who your current broker is and the length of this relationship?	
	Answer	CRRA solicits broker/consultants every three years. Our current contract which began 01/01/06 is with Aon Risk Services.	
10.	Question	Can you provide us with an estimate of the current annual fees which the CRRA pays its current broker?	
	Answer	We prefer not to disclose our fee structure at this time other than to say it is an annual payment and there are no commissions paid to the broker/consultant.	
11.	Question	Will there be an opportunity for an oral presentation to select firms who qualify as finalists.	
	Answer	There is room in the schedule to interview firms during the timeframe of $09/15 - 09/19$ if CRRA believes it would be beneficial.	
12.	Question	Can you provide us with a copy of current Schedule of Insurance that provides effective dates, insurers, premiums, limits, deductibles, self-insured retentions, etc.	
	Answer	Please see the attached pages for the current levels of coverage. I also refer you to the answer to questions 1 and 2 above.	
13.	Question	Can you provide currently valued loss runs for GL, AL, WC and Property/B&M in the form of an excel spreadsheet? We would like to do some analysis on the claims and provide some sample reports in our response.	
	Answer	Please see answer to question 3 above. You may provide sample reports you prepared for other clients with appropriate redactions.	
14.	Question	If you are unable to provide the loss runs, can you at least provide us with number of claims by coverage type and policy term for each of the past five years? This will at least allow us to better understand your claims volumes and service needs when developing our fee structure.	
	Answer	CRRA does not have a large volume of claims; currently four (4) in litigation involving public officials and pollution coverages. Additional detail re claims will be shared with the selected proposer.	
15.	Question	Can you tell us how many owned/leased vehicles are in your fleet?	
	Answer	CRRA currently insures 38 owned vehicles. Of these vehicles approximately 13 are tractors/trailers and other heavy trucks; others are light trucks and passenger vehicles. CRRA also has one transport plate.	

16.	Question	Can you tell us how many employees CRRA has?		
	Answer	Currently 61 full time; 7 part time		
17.	Question	Can you provide us with a current structure of CRRA's risk management team?		
	Answer	CRRA has one full time risk manager who reports to CRRA's Chief Financial Officer. CRRA also has an in-house counsel.		
18.	Question	Exhibit A – "The Scope of Services" does not appear to make any reference to actuarial services. However, Question #11 of Section 12 – "Issues and Questions to be Addressed" specifically requests us to describe our firm's ability to provide actuarial services. Can you please confirm if Actuarial Services are required as part of the Scope of Services in this RFP? If they are to be included, can you describe exactly what actuarial services you are looking to be performed as part of this engagement?		
	Answer	Please see Exhibit A to the proposed Agreement – Scope of Services. Section 2 of Exhibit A (page 3 of 4) outlines work that may require actuarial expertise.
