

ADDENDUM NO. 1 Issued February 3, 2010

Note: Statement Of Qualifications submitters are required to acknowledge this and all Addenda in Section 5(a) of the Statement Of Qualifications Form.

This Addendum consists of the Connecticut Resources Recovery Authority's ("CRRA") responses to written questions that were received by CRRA by 3:00 p.m., February 1, 2010, the deadline specified in the "Instructions to Firms" for the submission of written questions.

1.	Question	The Background Questionnaire asks if the proposer has ever been the subject of a "civil investigation." Please clarify the definition of "civil investigation?" (i.e., does it mean or include "civil lawsuit?"
	Answer	The phrase "civil investigation" in the Background Questionnaire is used to distinguish such investigations from criminal investigations. "Civil investigation" means an investigation undertaken by a governmental entity (e.g., federal, state) that has investigatory and enforcement authority (e.g., the Office of the Connecticut Attorney General, the Connecticut Ethics Commission, the Connecticut Elections Enforcement Commission, the federal Securities and Exchange Commission).
2.	Question	Will an SOQ submitter receive a stronger evaluation if it can provide all of the services, or will CRRA look equally favorably on a company that can only provide several services, but not all?
	Answer	CRRA's objective in issuing the Request for Qualifications is to enter into only one contract with a firm that is qualified to fulfill all of the Categories of Services specified in the Scope of Services."
3.	Question	Is it possible to obtain a version of the RFQ in an electronic, editable format (such as a Word document)?
	Answer	The portions of the RFQ that require the SOQ submitter to provide information or a response are provided on the CRRA web site in Word format.
4.	Question	Is it acceptable to use more than the space provided in the RFQ forms to respond to questions presented in the RFQ (this especially pertains to the forms in Section 6 – Business Information)?
	Answer	The RFQ forms that are available in Word format are designed to expand if an SOQ submitter requires additional space. Alternatively, it is acceptable to an SOQ submitter to attach additional sheets to the form if that is the submitter's preference.
5.	Question	Is there a limit to the number of pages that can be submitted as addenda/appendices to the SOQ?
	Answer	No, there is not a limit on the number of pages that can be submitted for an SOQ, but CRRA does value brevity and conciseness.

6.	Question	Could you provide the winning fee schedule from the Economic Advisor Services solicitation conducted in 2006?
	Answer	CRRA declines at this time to make available the fee schedule from the entity selected through the 2006 Economic Advisory Services RFQ.
