1.	Question	We are submitting completed project examples and our "solution" to a section of the proposed exhibit on a CD. Will you require a CD for each of the five copies submitted?
	Answer	Yes.
2.	Question	May we submit references for both ourselves and our subcontractor?
	Answer	Proposers should include any references for themselves and/or subcontractor that they feel best represents their proposal, though they are encouraged to strive for a balance between thoroughness with readability.
3.	Question	May we include extra copies of the References sheet to include more references than the three provided for?
	Answer	Proposers are able to use additional copies of the reference sheets and include as many references as they feel best represents their qualifications, though they are encouraged to strive for a balance between thoroughness with readability.
4.	Question	Is this a LEED project?
	Answer	This project is about recycling and energy efficiency so Proposers are asked to include as much recycled-content and energy efficient materials as are viable into their proposals. However, the project is not seeking U.S. Green Building Council LEED certification.
5.	Question	At some point in the design, if the budget doesn't allow for both, is CRRA in- terested in having more recycled content or more "exhibit." Is there a specific percentage of the budget dedicated to recycled-content
	Answer	CRRA has not designated a set percentage of the budget for recycled content materials. While we want to maximize the aesthetics and impacts of the exhibits, in general CRRA is committed to maximizing recycled content and energy efficiency in this exhibit.
