Non-Budgeted Expenditures

November 30, 2006

Discussion

Section 3.3 of CRRA's Procurement Policies & Procedures, <u>Non-Budgeted Expenditures</u>, states that any non-budgeted expenditure in excess of \$5,000 for acquisition of real or personal property or Personal Services shall require CRRA board approval.

At this time, it is believed that Personal Services includes Professional & Technical Services, such as the engineering and environmental consulting services provided under the three year engineering services and solid waste consulting services agreements that CRRA has with a number of engineering and solid waste consulting firms.

At this time, CRRA management seeks Board approval for four separate Request for Services (RFSs) for which funds are not currently available in the specific project accounts from which these activities would typically be paid.

All of these RFSs are less than \$50,000 in consideration, and typically would not be presented to the Board of Directors for approval; however, because the funds are not currently available in the specific account from which these expenditures would typically be paid, CRRA management believes it is prudent to present these RFSs to the board of Directors for approval pursuant to Section 3.3 of CRRA's Procurement Policies & Procedures.

A resolution for each of the RFSs, along with a contract summary sheet is presented below for each of the four separate RFSs.

Financial Summary

The RFS with Alternative Resources, Inc. will be funded from the Mid-Connecticut Project budget using anticipated surplus funds from the Fiscal Year 2007 operating budget.

The RFS with Gershman, Brickner & Bratton, Inc., for preparation of an opinion paper will be funded from the General Fund budget, using anticipated surplus funds from the Fiscal Year 2007 operating budget.

The RFS with Gershman, Brickner & Bratton, Inc., for assistance with landfill development and strategic planning matters also will be funded from the General Fund budget, using anticipated surplus funds from the Fiscal Year 2007 operating budget.

The RFS with Gershman, Brickner & Bratton associated with the Stratford Recycling Facility will be funded from the Bridgeport Project operating account.
